**Parade Route:** Arrive by 5:45 p.m. at Cimmaron Basin to depart at 6 p.m. Boats depart to ICW, turning south passing Tidelands, Marina Cove, Legacy Vacation Resort, under the Hammock Dunes Bridge along St. Joe's Walkway, Canopy Walk, and Waterfront Park, turning at the Grand Haven gazebo, passing Island Estates, and the Hammock and Yacht Harbor Village. The Parade disburses at the entrance to Clubhouse Waterway. **Accompanied by Tow Boat US Palm Coast, the Florida Fish and Wildlife Conservation Commission, and the Flagler County Sheriff's Office**

**Boat Captains' Meeting: REQUIRED ATTENDANCE!! December 15, 10 a.m., Marina Cove, 48 Rivers Edge Lane, Palm Coast, Florida 32137**

*All boats must be lit and decorated with a holiday theme. Vessel must carry operable regulation running lights and must be able to travel the full distance of the parade route (3.8 statute miles) under power at 5 knots. Boats must carry an operable VHF radio and proof of insurance and registration.*
